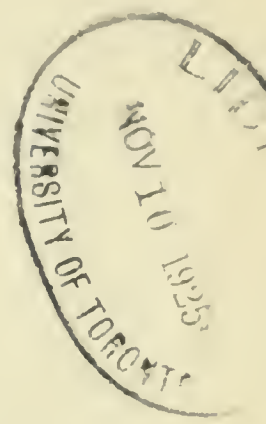

ANNUAL GENERAL MEETING, 1925.

The Twenty-first Annual General Meeting of the Society will be held at 5 p.m. on

TUESDAY, 17TH NOVEMBER, 1925,

at 22 Russell Square, by kind permission of the President and Fellows of the Royal Historical Society. An address on Episcopal Registers will be given by the Right Rev. the Bishop of Truro.

Tea will be served at 4.30.

THE REPORT

THE Council submits the following report and statement of accounts for the year ending 30th June, 1925, for the consideration of the Society.

There have been issued :

Part LXXV. The conclusion of the Register of Richard of Gravesend, Bishop of Lincoln (Part III).

Part LXXVI. The continuation of the Register of Robert Winchelsey, Archbishop of Canterbury (Part III).

The thanks of the Society are due to the Rev. F. N. Davis, the Rev. Canon C. W. Foster, and Professor A. Hamilton Thompson for the Lincoln Register, and to Miss Rose Graham for the Canterbury Register.

For the year 1926-27 it is proposed to issue the Winchester Register of Cardinal Wolsey, for which the governing body of Christ Church, Oxford, generously contributed £25, and the conclusion of Visitations of Religious Houses, Lincoln diocese, 1436-49 (Part II).

The Treasurer's financial statement will be found on page 6. £69 6s. 7d. has been realised by the sale of back parts. The cash balance at the Bank on 30th June, 1925, is lower than on 30th June, 1924, on account of the heavy expense of Part LXXV (Part III of Richard of Gravesend), which is given to members of the Lincoln Record Society. In the year 1926-27 the members of this Society will receive Visitations of Religious Houses, 1436-49 (Part II) in exchange as a gift from the Lincoln Record Society.

Eight new members have joined the Society : The Right Rev. the Bishop of Worcester ; the Rev. R. Dew ; Mr. H. G. Harrison ; the Rev. Lionel Lambert ; the Rev. H. G. Rosedale ; the Bede Library, London ; the University College of South Wales and Monmouthshire, Cardiff ; and the Illinois University Library.

The Council records with much regret the deaths of Lord Curzon, Mr. G. G. Phillimore, and Mr. Hall, the Controller of the Oxford University Press, who has taken great interest in the work of the Society and helped it in every way. No resignations have been received. There are now ninety-four libraries and ninety individual members, making a total of 184 ; and of these thirty-nine have joined in the last three years.

On the occasion of the twenty-first anniversary of the Society it is of interest to review the publications. In conjunction with the Cantilupe Society the complete set of the extant Hereford Registers

from 1275 to 1539 has been issued; by co-operation with the Lincoln Record Society there have been issued the thirteenth-century Lincoln Registers from 1209 to 1279, two volumes of Visitations of Religious Houses (1420-49), and Episcopal Records 1571-84. There have also been issued the London Registers from 1304 to 1338, the Winchester Registers of Pontissara (1282-1304) and White (1556-59), the Carlisle Register of Halton (1292-1324), and the Chapters of the Augustinian Canons (1216-1518). In the next few years it is intended to complete the registers which are now in progress, viz.—those of Archbishops Peckham, Winchelsey, and Parker, which are of outstanding importance as registers of the province of Canterbury as well as of the diocese; the London Register of Simon Sudbury, the Rochester Register of Hamo de Hethe, the Salisbury Register of Simon de Gandavo, and the Winchester Register of Stephen Gardiner.

By an arrangement with the Surtees Society, the Registers of the Archbishops of York will be issued to members of this Society, beginning with Archbishop Greenfield (1306-15). The issue of Lincoln Registers will be continued in co-operation with the Lincoln Record Society. Negotiations are in progress for co-operation in completing the publication of the Exeter Registers, which was begun by the late Prebendary Hingeston Randolph and continued by the late Rev. O. J. Reichel.

The Council desires to call the attention of members to an article on 'Episcopal Registers' by the Rev. Professor C. Jenkins in the *Church Quarterly Review* for October 1924, and a paper, also by Professor C. Jenkins, on Cardinal Merton's Register in *Tudor Studies*, edited by R. W. Seton Watson, and to the publication of a complete index of the series of Hereford Registers (Messrs. Wilson and Phillips, Eigne Street, Hereford), price 10s.

The offer to subscribing libraries to acquire the set of parts issued before June 30th, 1922 (excluding the register of Hugh de Wells), for £5, and to other members for £6, was renewed at the last annual meeting, and separate back parts can also be purchased by members at a reduced rate on application to the Hon. General Editor, Miss Rose Graham, 12 Ladbroke Gardens, London. W. 11. Part III only of the register of Hugh de Wells, Bishop of Lincoln (1209-35), is out of print. It is hoped to reissue this part by the cheaper process of photography, and members who require the complete set of eight parts of Hugh de Wells are requested to apply to the Hon. General Editor.

RULES OF THE SOCIETY

I.—The object of this Society shall be to print, for distribution among its members only, Copies, Abstracts, and Indexes of the Bishops' Registers and other Ecclesiastical Records in the Provinces of Canterbury and York.

II.—The Annual Subscription shall be One Guinea, payable in advance on the 1st July.

III.—Each member of the Society, having paid his subscription, shall be entitled to a copy of every work produced by the Society, and to vote at the general meetings, within the period subscribed for.

IV.—The management of the Society's affairs shall be vested in a Council consisting of the Presidents, the Vice-Presidents, Chairman of Council, Treasurer, Honorary General Editor, and one, or more, Honorary Secretaries, and twelve ordinary members, to be elected annually; but vacancies occurring between the general meetings shall be filled up by the Council. The Council may, if they think fit, elect a Chairman from outside their own body.

V.—A General Meeting of the Subscribers shall be held annually in the autumn to receive the Secretary's Report on the work and proceedings of the Society, and the Treasurer's Financial Statement; to elect officers for the ensuing year; and to transact the business of the Society generally. Notice of any business to be brought forward shall be given to the Secretary at least three weeks before the date of this Meeting.

VI.—The Council shall meet when necessary for the dispatch of business, three forming a quorum, including the Secretary. Presidents and Vice-Presidents shall not be summoned to meetings of the Council unless they shall have given notice in writing to the Secretary of their desire to serve upon it. The Chairman of the Meeting shall have a casting vote.

VII.—These Rules may not be amended or altered except at the Annual General Meeting, and notice of any proposed change shall be given to the Secretary at least three weeks before the date of the Meeting at which it is to be considered.
